An all-island multisectoral conference on obesity

On behalf of the Health Promotion Agency for Northern Ireland and the Health Service Executive, Republic of Ireland, we would like to invite you to attend a one day conference on obesity in the Europa Hotel, Belfast on 13 November 2008.

The World Health Organization reports that overweight and obesity have reached epidemic proportions globally and estimates that approximately 1.6 billion adults and at least 20 million children under the age of five are overweight or obese. It is accepted that being overweight or obese increases the risk of health conditions such as heart disease, stroke, diabetes and some cancers and has significant impacts on a wide range of other factors including education, employment and emotional wellbeing.

Across the island of Ireland the number of children and adults who are overweight or obese continues to rise. Northern Ireland has introduced a cross-departmental action plan and the Health Service Executive in the Republic of Ireland has developed a Framework for action on obesity to tackle this issue.

This conference aims to present a multisectoral audience with the latest developments in overweight and obesity prevention and management. It will provide the opportunity to discuss how we, in our various settings, can influence the development of national, regional and local approaches to help combat overweight and obesity throughout the island of Ireland. The conference will be of particular interest to those involved in policy development and planning within healthcare, local authority, education, food industry, childcare, agriculture, sporting, community and voluntary organisations. We hope to empower participants to work more closely together to tackle the challenges of an increasingly sedentary lifestyle and obesogenic environment by drawing on a range of international, national and local speakers and detailing best practice initiatives in a range of settings.

Following the conference there will be an Obesity surveillance symposium on Friday 14 November to investigate the best way forward in setting up a national database on overweight and obesity across the island.
